Summary

Theories addressing human needs and values have held a prominent position in the field of social sciences for an extended period, going back several decades (Hoffman, 1988). Despite the diversity in terms of approach and practical applications, these theories share a unifying goal: to decipher the essential principles that underlie human behaviour, the decisions made, and the aspirations pursued (Tay & Diener, 2011). In this series of reports, four representative theories are examined: Abraham Maslow's Hierarchy of Needs Theory, Milton Rokeach's Theory of Types of Values, Shalom Schwartz's Theory of Value Structure, and Geert Hofstede's Theory of Cultural Values. Through their respective approaches, these theories provide insight into the intricate web of values and needs that make up the human experience (Kenrick et al., 2010).

This report examines Geert Hofstede's theory and its potential empirical application in various European societies, using the securities data collected in Eurobarometer 98.2 (2023). Given the nature of the data, which were collected for other purposes, the analysis is exploratory and necessarily fragmentary. In relation to the exploratory application of other simpler models, Hofstede's model contains six dimensions defined on the basis of alternative subdimensions. Given that the number of values asked about in the questionnaire is limited, and they are also predefined, the increase in the variability to be measured has an impact on the ability to measure. A limitation that comes from the lack of variables that collect enough values to operationalize all dimensions.

In this sense, in general, the more dimensions to be measured, the more exploratory, as fragmented, the measurement will be. On the positive side, however, it should be noted that such fragmentation applies in a similar way in all the countries considered; On the negative side, the dimensions that cannot be measured are the most prominent in some of the countries, transferring to others the weight (as relative percentages) that would correspond to them.

The research pursues two main objectives. The first is to design and evaluate the results of an exploratory measurement based on Geert Hofstede's model. The second

objective is to provide useful information for application in different societies. The analysis has identified significant patterns in several of the societies studied. In particular, this study observes the existence of a socio-demographic or ideological basis that underlies the value structure of some of the societies considered. This provides an opportunity for researchers with a deeper understanding of the historical experiences of such societies to deepen this relationship.

The measurement obtained has been adjusted according to two dimensions. The first dimension refers to the socio-demographic and economic conditions of the respondents, considering variables such as gender, age, and economic difficulties. Economic hardship can be interpreted as an indirect indicator of social position. The second dimension of an ideological nature considers the variable of ideological positioning on a scale from left to right.

In order to facilitate the analysis individualized by country, this control has been included for each of them. When carrying out this analysis, it is important to consider at least two conditions. The first concerns age ranges. Age can be indicative of belonging to a generation, an age cohort, as well as the aging process. These three factors can lead to cross-interpretations. For example, a linear association may reflect psychological maturation, but also belonging to different generations or cohorts. And vice versa. The absence of a relationship may be due to the fact that the established age ranges combine people from different generations, which blurs the generational effect. Researchers interested in digging deeper into a specific country are advised to assess which age ranges best reflect the generational dimension for each country.

As for ideology, it is grouped into three intervals, identifying the left with positions 1 to 4, the centre with positions 5 and 6, and the right with positions 7 to 10. It is well known that each society defines itself politically with specific referents, such as the alternative scales of liberal and conservative. This analysis is indicative, so it is advisable to consider the system of ideological categories of each country.

However, there are a number of interesting conclusions to be drawn. Unlike dichotomous models, such as Rokeach, models with more than two dimensions show a differentiated sociodemographic structural basis according to which values. The

value system appears to be associated with different social realities according to their content. Thus, in Hofstede's model, the economic situation tends to be associated with the dimension of uncertainty, that of femininity with gender or age. Age, as a generation, is associated with the greater presence of restriction or indulgence, expressing different cultural climates of socialization. Power, individualism, and collectivism have their best association with ideological location.

In short, it is observed how the configuration of the value system is conditioned by different sources and social situations. In this sense, the question arises: how is the internal balance of the value system established? Which values are coherent with each other, and which generate dissonance? Is there a relationship between social crises and internal conflicts between the dimensions that shape the value system?

In any case, the results are in line with Hofstede's argument that the dimensions that make up the value system are stable, although they modify their intensity (cultural prevalence) as a function of social change.

However, as far as this report is concerned, it can be concluded provisionally and exploratorily that there is a greater or lesser relationship between the Hofstede scale and the dimensions considered, either with the objective sociodemographic and economic dimension or with the ideological dimension. Of the forty societies considered, 33 of them show an association between the values of the Hofstede model and the dimensions of political ideology. In 30 countries, there is evidence of a generational structure, in 31 an effect of economic position, and in 17 societies there are gender differences. Thus, it can be observed that values are more closely linked to subjective variables of an ideological nature. However, the effect of generational change and the diffusion of different values depending on the economic situation of the interviewees is very significant.

In Switzerland, Cyprus, Slovakia, Poland, Finland, the United Kingdom, Luxembourg, and the Netherlands, it can be seen that the Hofstede value model is associated, in some of its dimensions, with the five variables considered. In short, in these societies the structure of values is clearly referenced in the social and ideological

structure, the latter expressed in terms of political ideology. It cannot be forgotten that political ideology is, among other things, a way of seeing the world.

Certainly, the existence of a greater number of axiological dimensions facilitates the association between any of them and the control variables considered. In general, value models that contain greater diversity offer a greater number of points of contact with sociodemographic and ideological control variables.

Due to their specialization and dedication, it is not possible to analyse each of these societies. Among the reasons already mentioned, each researcher must decide, based on the historical experience of each country, how the generations succeed each other. Obviously, the historical experience is not the same in the countries of Eastern Europe compared to the West, nor between late democracies such as Spain, Greece, or Portugal and those that did not experience dictatorships after World War II.

However, this analysis provides a basis for the development of other studies at the national level by identifying which variables are significant for further study.

1. Introduction

Geert Hofstede developed in the 1980s a theory that provides a framework for understanding cultural differences across several key dimensions (Hofstede, 1984). These dimensions, though simplified, provide a powerful framework for understanding cultural differences and predicting behaviours in cross-cultural contexts (Hofstede, 1980). Hofstede's theory of cultural dimensions, developed by Dutch management researcher Geert Hofstede, is a framework used to understand cultural differences between countries.

Hofstede originally identified four cultural dimensions, which were later expanded to six, based on an extensive survey of IBM employees in more than 50 countries. According to the author, these dimensions represent universal aspects in which cultures differ from each other.

Hofstede's proposed original dimensions include:

Distance to Power (PDI): Measures how societies address inequalities between people. Consider the extent to which inequality and power are tolerated. A distance to high power index indicates that a culture accepts inequality and power differentials, fosters bureaucracy, and shows high respect for rank and authority. Some cultures accept a steeper hierarchy, while others seek more equality.

Individualism vs. Collectivism (IDV): Reflects the relationship between individuals and their groups of belonging. Individualistic cultures value autonomy and self-expression, while collectivist cultures emphasize group harmony and family relationships. This dimension considers the degree to which societies are integrated into groups and their perceived obligations and dependence on groups.

Masculinity vs. Femininity (MAS): It deals with gender roles and how societies value characteristics such as competitiveness (masculinity) versus cooperation and care (femininity). It is a psychological dimension that considers femininity versus masculinity, understanding the masculine as aggressiveness and competitiveness while the feminine represents care and cooperation. It is in these terms that societies or social groups can be more masculine or feminine. Indirectly, their greater or lesser femininity can be observed through the distribution of roles between the genders within a culture.

Uncertainty Avoidance (UAI): Indicates a society's comfort level with ambiguity and uncertainty. Some cultures look for structure and clear rules, while others are more tolerant of ambiguity.

Subsequently, Hofstede and colleagues added other dimensions, such as Long-term vs. short-term orientation and Indulgence vs. Restriction (Hofstede et al., 2011).

Long-Term Orientation vs. Short-Term Orientation (LTO): Describes how societies maintain links to their past while facing the challenges of the present and future, with long-term oriented societies being more pragmatic and future-oriented. This dimension describes how each society has to maintain some links with its own past while facing the challenges of the present and the future.

Restriction vs. Indulgence (IVR): Indicates the degree to which people try to control their desires and drives based on the way they were socialized. This dimension is defined as the degree to which people try to control their desires and impulses.

Each of these dimensions exists on a continuum from low to high, and each country exhibits varying degrees of multiple traits. The theory suggests that cultural values are social constructs, which are ideas in the world developed by people, and can differ between different groups and change as time passes.

Hofstede's six key dimensions, a) distance from power, b) avoidance of uncertainty, c) individualism-collectivism, d) masculinity-femininity, and e) short-term vs. long-term orientation and f) restriction vs. indulgence allow different countries and cultures to be compared. The degree to which individual countries share key dimensions depends on several factors, such as shared language and geographic location. Hofstede's cultural dimensions are widely used to understand etiquette and facilitate communication between cultures in areas ranging from business to diplomacy.

Hofstede's theory has been fundamental in fields such as intercultural management, marketing, and international relations (Hofstede, 2001). However, it has also faced criticism, particularly regarding the generalization of national cultures and the rigidity of dimensions. Cultural dimensions are oversimplified and do not fully capture the complexity of cultures (McSweeney, 2002). Thus, it is important to note that although these dimensions provide a useful framework for understanding cultural differences, they are neither definitive nor exhaustive. Cultures are complex systems with many interrelated parts, and this theory is just one lens through which to view them.

Despite its widespread use, Hofstede's theory has been criticized for its methodology and for overlooking historical and political context. Some critics argue that the theory oversimplifies cultural differences and reduces cultures to static categories. Others point out that the theory is based on data from a single company (IBM) and may not be representative of entire nations or cultures (Baskerville, 2003). Despite these criticisms, his theory remains a benchmark in the study of cultural differences (Taras et al., 2010). In conclusion, Hofstede's Theory of Cultural Dimensions provides a

valuable framework for understanding cultural differences. However, like any theory, it has its limitations and should be used as one of the many tools in our kit for understanding human behaviour.

2. Objectives, operationalization and data

The first objective of this study is to evaluate the value structures proposed by Hofstede using the lists of values contained in the Eurobarometer questionnaires. These are personal values prioritized by the interviewees. Undoubtedly, this is exploratory research that presents methodological challenges. However, since categorization is applied in the same way in all countries, it provides a panoramic comparative view.

The second objective is to use measurement to determine whether or not there are associations with fundamental variables. Again, due to the large number of countries, this exploration offers basic clues for other researchers, more familiar with their own country and their historical experiences, to deepen the study.

The purpose of the measurement is mainly descriptive, although the validity of these measurements is evaluated by comparing them with other variables of an ideological nature, such as self-positioning on an ideological scale from left to right. It is crucial to highlight, in relation to the implementation of the models considered, the limitations that arise in their use as an empirical measurement. In this sense, it is important to mention that the models are not fully operationalized, since variables may be missing to measure some dimension considered in the specification; In addition, the correspondence between the theoretical concept and the value for which it is asked is established deductively. Therefore, a "proxy" application is made to the measured variables. Both elements reflect the exploratory nature of the research.

Another aspect to consider is the comparison between countries, i.e., the usefulness of the models to compare between societies. Thus, Maslow's and Rokeach's theories propose universal value structures (in the form of aspirations or motivations); Both theories have received criticism about their applicability in different cultural contexts. Other models are based precisely on considering national and cultural diversity. In the case of Schwartz's and Hofstede's theories, they emphasize cultural dimensions.

Schwartz focuses on the idea of a universal value structure, while Hofstede focuses on the differences between national cultures.

Operationalization

The values or sets of personal values asked about in the Eurobarometer survey are as follows:

- The Rule of Law
- Respect for human life
- Human rights
- Individual freedoms
- Democracy
- La Paz
- Equality
- Solidarity, support for others
- Tolerance
- Religion
- Personal fulfilment
- Respect for other cultures
- Respect for the planet

A list that partially responds to the value structures we have considered so far. In practice, many of the terms refer to a cluster of values and not just one of them, such as "religion" or "democracy". To the extent that the analysed survey corresponds to secondary data, not all values are accommodated in the classifications. It is common in the analysis of data that has been generated for a purpose other than the objective of the analysis (Alaminos, 2009).

As we have considered, Geert Hofstede's Theory of Cultural Values focuses on how cultures vary in relation to six key dimensions: Power Distance (PDI), Individualism vs. Individualism. Collectivism (IDV), Masculinity vs. Collectivism Femininity (MAS), Uncertainty Avoidance (UAI), Long-Term Orientation vs. Long-Term Orientation Short-Term Guidance (LTO), and Restriction vs. Leniency (IVR).

On the basis of the values included in the reference questionnaire, we propose to consider their classification as follows.

1. Power Distance (POI):

The *Rule of Law*: In cultures with high IDPs, the rule of law may be seen as a means of maintaining order and structure and may be less questioned by citizens.

2. Individualism vs. Individualism Collectivism (IDV):

Individual freedoms: They are more valued in individualistic cultures where personal autonomy is prioritized.

Solidarity, support for others: These concepts align more with collectivist cultures that emphasize the importance of community and interdependence.

Religion: In many cultures, religion emphasizes community and belonging, which can align with collectivism.

3. Masculinity vs. Masculinity Femininity (MAS):

Peace: In women's cultures, quality of life and well-being are prioritized, and peace can be a core value.

Equality: Female cultures tend to value equality and fairness.

4. Uncertainty Avoidance (UAI):

The *Rule of Law*: Cultures with high IAU may rely more on the rule of law to provide structure and predictability.

Human rights: They can be seen as fundamental in cultures with low IAU, where diversity and freedom are valued.

5. Long-Term Orientation vs. Long-Term Orientation Short-Term Guidance (LTO):

Personal fulfillment: In long-term-oriented cultures, there may be an emphasis on perseverance and adaptability, which can relate to self-actualization over time.

Respect for the planet: This value suggests a long-term perspective, considering the well-being of future generations.

6. Restriction vs. Restriction Forbearance (IVR) :

Tolerance: Indulgent cultures tend to be more tolerant and permissive, valuing freedom of expression.

Religion: Depending on how it is practiced, it can be associated with restriction, especially if it focuses on strict norms and rules.

According to the previously established classification, several multiple-choice variables have been developed. A multiple-choice design has been chosen to allow certain variables to be integrated into the operational definition of various values. This strategy is analogous to that employed in latent variable designs, where an indicator variable can be associated with different factors.

In this context, the covariation between the indicator variable and the latent variables (values) does not derive from an empirical imposition, but from a theoretical intention. Since some of the variables used can be integrated into the definition of different values, the ambivalent or diffuse measurement nature that is present in some of the variables used to measure the reference values has been incorporated.

As previously mentioned, the questions have been designed as multiple answers with a maximum of three options, integrating the voting motivations into a single question. This operationalization of measurement has positive implications by providing greater autonomy to the interviewee. However, it imposes a limitation on diversity by setting a maximum of three responses per interviewee. This limitation makes it necessary to select the most significant options, which is very beneficial, although on the other hand, it prevents the joint evaluation of all motivations.

A second consideration is the need to remember the operational and theoretical meaning of multiple responses, the format given to them and, in particular, the difference between using cases or answers as a basis. In general terms, the multiple response, depending on the measurement to be carried out, can generate biases

derived from the cognitive qualification or the level of information of the interviewees.

This fact is accentuated when the design of the question offers a list of categories from which to choose, especially when it is excessively long. However, the rotation of options controls the bias by which the first and last categories are prioritized. The strategy of establishing dichotomous multiple responses is much more appropriate, as it allows each option to be evaluated one by one, although the cost in time is much higher.

The need to control the possible dependence between the sociodemographic traits of the interviewees and the topic being asked becomes essential. The specificity of the topic to be measured limits the response options (based on interest or knowledge) of the interviewees. A potential bias that is invisible in its statistical treatment as a multiple response.

Data

The data used correspond to Eurobarometer 98.2 (2023). Table 1 shows the distribution of the interviews conducted by country.

For its treatment, each country has been weighted in such a way that the sample is internally balanced. As specified in the barometer's data sheet: "For each sample (lower-level country or region), through the post-stratification weighting procedure, a comparison is made between the composition of the sample and an adequate description of the universe. The description of the universe is available from the National Survey Research Institutes and/or EUROSTAT. On this basis, a national weighting procedure is applied, using marginal and intercellular weighting. Thus, in

all countries, sex, age, NUTS II region (basic regions defined by Eurostat's nomenclature of territorial statistical units) and locality size are entered into the iteration procedure. This post-stratification weighting is also known as compensation or non-response weighting. There is no design weighting that adjusts for the unequal selection probabilities (depending on the size of the household)."

1. Analysis

The answers obtained by multiple response, whether operationalized in category lists or in dichotomous multiples, form a set from which the frequency distributions are extracted. Which elements make up the set give rise to two presentations of the multiple answer. On the one hand, using the number of cases as a basis, or on the other hand, using the number of responses that have been obtained as a basis. The two procedures allow for differentiated analytical use.

Case Base

If the set used as a reference to calculate the frequencies are the cases, these frequencies add up to more than 100. An example, suppose a sample of 1000 cases is administered a multiple-choice question with the possibility of choosing two options. 1000 cases respond at least by choosing one answer and of those 1000 cases, 500 cases respond to two. The basis, requested in cases, is 2000 cases (1000 possible cases to one answer + 1000 possible cases to the second answer); As 1500 cases have responded, the sum of percentages of the different answers chosen will result in 150%. This is relevant information, given that we know that 50% of the cases only said one option and 50% said two. That is why the magnitude of the base depending on the cases depends on the number of answer options. A single possible answer establishes a 100% baseline. With two possible answers, the base is 200%, with three it is 300%, and so on. It will be the difference between the sum of percentages in the multiple response based on cases and the possible reference percentage based on the allowed number of responses, which informs the internal structure of the non-response. This type of case-based analysis is important to monitor and evaluate the effect of non-response patterns that may be contained in the whole. In general, it is used to assess each country specifically.

Answer base

When the multiple answer is expressed on the basis of the answers, its sum gives 100%. The reference to the percentage of people interviewed who offered a lower number of answers is lost. However, it offers a standardized expression of the weight offered by each motivation or response. As a standardized expression, it allows for a comparison between countries. In this case, it will be used to compare the motivational patterns of the different countries.

The following tables show the response structures based on responses or the number of cases.

Using the response base standardizes the results so that they add up to 100% for each country. Its effect can be seen in the graph below. The case-based analysis offers differentiated and complementary information to that observed above regarding the use of the response base.

As has been repeatedly mentioned, this is an exploratory study to determine what configuration the value models would adopt based on those present in the questionnaire. In any case, it is important, in addition to the measurement, to evaluate its association, if any, with other significant variables. The variables referring to sociodemographic and ideological traits are especially interesting as they reveal how values are articulated with the deepest inequalities and differences that form the backbone of society. The association between the values considered in the Hofstede model and the control variables considered is shown below.

2. Conclusions and debate

It is undeniable that the measurement of value structures in various societies is subject to multiple limitations, both methodological and theoretical. Most of these limitations come from the fact that we use a questionnaire that has not been explicitly designed

for the measurement of the value structure, which significantly influences the measurement. Next, the limitations that contextualize the measurements made will be considered.

A first limitation is due to the translation of values and motivations between different languages (Alaminos & Alaminos-Fernández, 2022). It is clear that there are differences in what values mean when translated, a limitation that has been the subject of specific study.

A second limitation arises from the list of values considered. In some cases, it does not ask about values that are included within the theories. For example, in the case of Maslow and his hierarchy of needs, he does not ask about the most basic ones. This results in a partial measurement, insofar as the catalog of eligible securities is incomplete.

A third limitation arises from the state-level analysis. Values, motives, or aspirations may be characteristic of specific social groups, groups that do not necessarily coincide with the state. Therefore, considering the state as a unit of reference implies homogenizing a potential diversity. In addition, social groups may be supra-state. In this sense, the adoption of the state as a unit of analysis is conditioned by the sample sizes used.

In any case, the classification of values using the Hofstede model offers an important ability to differentiate between societies in terms of values predominant in the population as a whole. Thus, several interesting conclusions can be drawn. Unlike dichotomous models, such as Rokeach, models with more than two dimensions show a differentiated structural basis according to which values. The value system appears to be associated with different social realities according to their content. Thus, in Hofstede's model, the economic situation tends to be associated with the dimension of uncertainty, that of femininity with gender or age. Age, as a generation, is associated with the greater presence of restriction or indulgence, expressing different cultural climates of socialization. Power, individualism, and collectivism have their best association with ideological location.

In short, it is observed how the configuration of the value system is conditioned by different sources and social situations. In this sense, the question arises: how is the internal balance of the value system established? Which values are coherent with each other, and which generate dissonance? Is there a relationship between social crises and internal conflicts between the dimensions that shape the value system?

In any case, the results are in line with Hofstede's argument that the dimensions that make up the value system are stable, although they modify their intensity (cultural prevalence) as a function of social change.

However, as far as this report is concerned, it can be concluded provisionally and exploratorily that there is a greater or lesser relationship between the Hofstede scale and the dimensions considered, either with the objective sociodemographic and economic dimension or with the ideological dimension. Of the forty societies considered, 33 of them show an association between the values of the Hofstede model and the dimensions of political ideology. In 30 countries, there is evidence of a generational structure, in 31 an effect of economic position, and in 17 societies there are gender differences. Thus, it can be observed that values are more closely linked to subjective variables of an ideological nature. However, the effect of generational change and the diffusion of different values depending on the economic situation of the interviewees is very significant.

In Switzerland, Cyprus, Slovakia, Poland, Finland, the United Kingdom, Luxembourg, and the Netherlands, it can be seen that the Hofstede value model is associated, in some of its dimensions, with the five variables considered. In short, in these societies the structure of values is clearly referenced in the social and ideological structure, the latter expressed in terms of political ideology. It cannot be forgotten that political ideology is, among other things, a way of seeing the world.

Certainly, the existence of a greater number of axiological dimensions facilitates the association between any of them and the control variables considered. In general, value models that contain greater diversity offer a greater number of points of contact with sociodemographic and ideological control variables.

In this sense, when considering society as a unit of analysis, the observed value structures are influenced by multiple factors. This leads to several explanatory hypotheses. Thus, the demographic and socio-economic composition of the population, the possible effects of migration and multiculturalism. Another possible explanatory factor is the effect of the transition to capitalism from communist regimes. In any case, it is clear that a more specific study is required to allow a better measurement of both the value structure and its relationship with the social structure. It's something that's only feasible with a purpose-built survey.

Considering the relationship of Hofstede's exploratory measurement with the sociodemographic and ideological dimensions, it is observed, in the first place, that the most frequent is the association with the ideological dimension, followed by age and economic.

It is observed that values are more closely linked to subjective variables of an ideological nature. It cannot be forgotten that political ideology is, among other things, a way of seeing the world.

Because of their specialization and dedication, it is not possible to analyse each of these societies. Among the reasons already stated, given that each researcher must decide based on the historical experience of each country how the generations succeed each other. Evidently, the historical experience is not the same in the countries of Eastern Europe compared to the West, nor between late democracies such as Spain, Greece, or Portugal and those that did not experience dictatorships after World War II.

This analysis offers, however, a basis for the development of other studies at the national level by identifying which variables are significant for further study.
