Training Sessions in a Master Degree "Informatics as a Second Competence"

Abstract—The ERAMIS acronym stands for European-Russian-Central Asian Network of Master's degrees "Informatics as a Second Competence". The aim of this project is to create a Master degree "Computer Science as a Second Competence" in 9 beneficiary universities located in Kazakhstan, Kirghizstan and Russia. One crucial aspect of the project is training. In this contribution we describe how training sessions have been organized, the pedagogical issues that are involved and ways to address them.

I. INTRODUCTION

Our world does not work anymore without Information Technologies. Almost every profession needs computers with adequate software. The production of this adequate software requires that the software developers understand the needs of the software users. Most of the time this understanding necessitates a person that understands both worlds: the world of the users and the world of the developers. This need has been recognized as early as 1987 at the University Pierre Mendès France in Grenoble, France where a Master "Informatics as a Second Competence" has been created. This degree is intended for students having a Bachelor in social sciences and therefore who are non Information Technology (IT) specialists. The Master's program objective is strictly professional, as it aims to train versatile people who will combine good skills (acquired in a Bachelor's degree) in the first discipline with theoretical and technical skills in computer science, enabling them to create, develop and implement tomorrow's software tools in a better way.

Following the model of the Master of the University Pierre Mendès France, a similar Master has been created in the Kyrgyz National University, Bishkek, Kirghistan [1]. Presently this model is further extended in the EU Tempus project ERAMIS [2]. The ERAMIS acronym stands for *European-Russian-Central Asian Network of Master's degrees* "Informatics as a Second Competence". This 3,5-year project is supported by the European Union (EU) in the Tempus Sergio Luján-Mora Department of Software and Computing Systems University of Alicante Alicante, Spain

scheme and involves five universities from five partner countries: Finland, France, Germany, Poland and Spain. It started in January 2010. Its aim is to create a Master degree "Computer Science as a Second Competence" in 9 beneficiary universities located in Kazakhstan, Kirghizstan and Russia. This degree is intended for students having a Bachelor in social sciences, exact sciences or engineering but who did not graduate in computer science. This Master is thus a geographical and disciplinary extension of the two already existing Masters.

The working-methodology adopted in the ERAMIS project is described in [2]. One crucial aspect of the project is training. [3] describes the faculty training put in place inside the project. The faculty training is completed by training sessions taking place in the universities of the beneficiary countries. In this contribution we describe how these training sessions in the beneficiary universities are organized and the pedagogical issues that are involved. Further we share ways to address some of the pedagogical issues and show how they have been put into practice with concrete examples of training sessions.

II. ORGANISATION AND PEDAGOGICAL ISSUES

A. Format of a Training Session

A training session is a course of 10 to 20 hours that takes place over 4 to 5 days. It is intended in the first place for students of the Master. The number of participants should be from 10 to 20. If place allows academic staff or other interested students form the beneficiary university can attend. A training session is taught by a member of a European university member of the project. The teaching language is mainly English, as very few persons form the European universities can speak Russian. Furthermore the ERAMIS project foresees that 20% of the teaching in the Master has to be done in English. Holding training sessions in English helps to meet this goal.

B. Putting up the Offer

The European Universities gave a list of training sessions they could offer according to the curriculum of the Master and to their respective strengths. Each beneficiary University expressed its wishes for the suggested sessions. From those wishes we could determine the sessions which would be organized and the universities which would host them. Sessions were distributed in a fair way among universities, depending on the competences of each of them and are shown in Table I.

C. Pedagogical Issues

They are several pedagogical issues that make teaching a training session different from the usual teaching in one's home university.

- The format of the training session means that one has to teach to the same students several hours a day and 4-5 days in a row. Students do not have one week to absorb the content of a day.
- Students have already a Bachelor degree, which means they already have a good level of maturity and motivation. However the topic of the training session is a topic in computer science at a Bachelor level.
- The exact level of the students (and also of the academic staff) in the topic taught is somewhat unknown before the training session begins.
- The level of English of the students may vary greatly and may not be very high. English is also a second language for all trainers.

III. WAYS OF ADRESSING THE PEDAGOGICAL ISSUES

An efficient way of addressing the pedagogical issues mentioned above is to practice content reduction as well as to encourage and require both interactions and motivation from students [4,5]. Practicing content reduction means selecting carefully not only the topics to be addressed, but also how deeply to address them and preparing a good outlook so that students get an idea of what they know and what they need to discover later in the field. Requiring and encouraging interactions and motivation means planning tasks where students have to be active and engaged, supporting them while solving the tasks and appreciating positively their activity. Content reduction makes it easier to adjust the teaching to the level and the absorption's capacity of students: no need to rush through the material. Requesting and encouraging interactions and motivation allows the teacher to be better aware of how well students follow, as she can check how students solve exercises, and whether they have difficulties in doing so.

In the following we give concrete examples how these principles have been put into practice in several training sessions.

A. Training Session Data Warehousing & Data Mining

This 20-hours training session was delivered over 4 days to about 12 students. Its description is given in Table 2.

Practicing content reduction meant in particular to cover only one technique per data mining area and one way to evaluate this technique, so as to still practice the data mining cycle entirely. For clustering the k-means algorithm and the evaluation "average within centroid distance" were selected; for classification the technique decision tree and the evaluation accuracy / confusion matrix were selected; finally for association patterns, the technique association rules and the interestingness measures lift and cosine were selected for evaluation.

A number of notions have not been lectured classically, the teacher explaining and the students listening. Instead they have been introduced through exercises that requested students to be active and engaged, that made them ask questions and explain what they discover, understand or don't understand. In the sequel several examples of such activities are given.

On the first day in the first half-hour students were given the data set shown in Table III, a modification of an original data set used in textbooks like [6,7], and had to find the missing, erroneous, duplicate and obsolete data. After this exercise it was easy for them to understand data cleaning and data preprocessing. A secondary effect of that exercise, as solving it requires no deep knowledge but common sense and observation skills, is that students gain confidence and become willing to speak in English, even if they can't express themselves completely fluently and have to ask their neighbors for words.

Many data mining techniques, for instance k-means clustering, require a distance to be calculated between two objects. When objects are described by attributes that are all numbers a common distance is the Euclidean distance. A characteristic of the Euclidean distance is that numbers with a great order of magnitude may impact the final calculation much more than small numbers. Students were not taught this characteristic. Instead, after making sure that they understand the formula, they were given the data shown in Table IV and had to answer the questions below it. The data in Table IV describe three persons with identity 1, 2 and 3 that are represented by two attributes: their weight in kilograms and their height in meters.

a. Use the Euclidean distance to calculate who is nearer to person 1: person2 or person 3. Show your calculations.

b. Create a new attribute called HeightInCm that gives the height of a person in centimetres. Use again the Euclidean distance and the attributes Weight and HeightInCm to determine who is nearer to person 1: person 2 or person 3. Show your calculations.

c. Explain the difference.

d. Give a way to calculate the distance using attributes that all have the same $\frac{1}{2}$ order of magnitude.

With this exercise students are at first puzzled because questions a and b give contradictory results though the same persons are handled, but they grasp quickly how attributes with big numbers may impact Euclidean distance. introduce transformations that put all data within the same range (last question). It makes also students more talkative and curious.

K-means clustering has a number of properties and pitfalls. One property is that outliers or extreme values tend to form they own small cluster. One pitfall is that this technique always returns a set of clusters, even if the data are random and do not cluster naturally. To boost curiosity and motivation of students and to be aware of how much they follow and understand, these two aspects were not lectured classically, instead students had to discover them with exercises using the tool RapidMiner [8]. Students had to explore three data sets, look visually for some natural clustering in the data using plots, run the k-means algorithm with different values for k, the number of clusters, and evaluate each clustering with average within centroid distance, a facility provided by the tool RapidMiner. Two data sets are given in Table V and represent points with their coordinates. The third dataset has to be constructed by students taking the original data of the set shown in Table I and selecting only the two quantitative attributes Temperature and Humidity.




Figure 1. Scatter Plot of the dataset showing no obvious natural clustering.

The first data set has 3 natural clusters. The second data set has one outlier, the last element. The data of the last data set do not cluster naturally. A scatter plot shows them more or less randomly distributed in the graph, see Figure 1.




Figure 2. Scatter Plot of the dataset Table V right showing the outlier in a cluster by itself.

Students observe that the outlier of the second data set forms a cluster by itself, whatever the value of k is, as illustrated in Figure 2 for k=2. They also observe the sharp drop of the average within centroid distance when k=3 in the first data set, which indicates that 3 is a good number of clusters, with k=4 for the second data set. However no such sharp drop can be observed for the last data set pictured in Figure 1, which indicates that a clustering pattern might not be discovered. This exercise makes students understand the importance of evaluating a pattern much more efficiently than any discourse and motivates them further.

A final example of requesting students' interaction and encouraging motivation is taken from the association rules area. The association rules technique aims at discovering rules like "if costumers buy beer and coke, then they also buy diapers". Such a rule gives a dependency between consequent, here "buy diapers" and the antecedent, here "buy beer and coke" and is often denoted by the short form "beer, coke \rightarrow diapers" [6,7]. In the same way as average within centroid distance helps evaluate the goodness of a clustering, lift and cosine are two measures that help evaluating the interest of an association rule found by the algorithm. As these two measures might give contradictory results, it is quite important to understand both their intuitive meaning and their different properties. One property of cosine that lift does not have is the so called null-invariant property [6,7], that will be explained shortly. Students had to discover it by themselves calculating cosine and lift of the rule $X \rightarrow Y$ for the three data sets shown in Table IV. Tid is the transaction identity of some customer who has bought items X, Y or Z. The first data sets contains only 5 transactions, the second data set 7 and the last one 10. The five first customers in the 3 data sets have all bought the same items. Customers 6 to 10 buy at most item Z. Calculations show that cosine $(X \rightarrow Y)$ has the same value for the 3 data sets while lift ($X \rightarrow Y$) increases: the smallest value is for dataset 1 and the highest value for dataset 3. Lift is sensitive to transactions containing neither X nor Y, while cosine is not. Cosine stays invariant when the data set is augmented with null-transactions with respect to the rule. This

result surprises students and makes them reflect deeper on the intuitive meaning of these two measures.

B. Training Sessions Database Design and Programming in T-SQL

The 10-hours training session Database Design lasted for 1.5 days, followed by 20-hours training session Programming in T-SQL on MS SQL Server 2008 – next 3 days. Both sessions were bound together and included the design and development of database queries in a particular Relational Database Management System (RDMS) – Microsoft SQL Server 2008. Their description is given in Table VII and Table VIII. The Database Design training session has been planned as the realization of a typical approach to design a Database (DB): from requirements to physical data model (in Relational Schema) and SQL Data Definition Language (DDL) commands to run on the DB server.

Classes in Database Design training was conducted as activating students' seminars, which consisted of the following activities:

- lectures (about 20% of the time),
- joint group exercises presenting techniques and CASE tool (30%),
- independent solving of case studies by students (40%),
- discussion and evaluation of the results of independent practice (10%).

Lectures were a theoretical introduction to DB design. They presented a position of design in an application life-cycle. In particular they presented typical techniques of defining requirements, such as user goals analyzing (Figure 3), events analyzing, CRUD (Create, Read, Update, Delete) – Figure 4, documents analyzing, things definition.

During the lectures a typical approach to the modeling of DB has been introduced, see Figure X, including the division into two types of models: Logical Data Model (LDM) and Physical Data Model (PDM). Principles, notation, and construction rules of Entity Relationships Diagram (ERD) as a model of LDM have also been described. Also the modeling problem of the inheritance in LDM was featured.

General ideas of relational schema (tables, keys, data integrity rules, indexes, views etc.) and problems of Entity Relationship Diagram transformation to Physical Model were presented during the lessons in details.

During the practical part of the training, students became familiar with one of the CASE tool used for DB modeling (Toad Data Modeler) and process of DB designing. Students designed the LDM for a case study of CAFE support software and mapped it into PDM. The case study concerned the DB design for a café shop support system called CAFÉ, chosen to motivate students. Students received one-page description of processes in a cafe shop. Based on this description students defined system users, created the goal analysis, found things and, using the CRUD technique, checked the completeness and correctness of their results.




Figure 5. Database modeling phases.




Figure 6. Logical Data Model for CAFE database (a part)

When the DB logical structure was ready, students prepared and performed presentations of the design results (models). After the presentations a brainstorming session was held. This session purposes were the formal verification of the models and the checking of the end-user fulfillment of software requirements. During the brainstorming session students developed the final LDM (Figure 6). Some student's teams rebuilt their solutions. Modifications were made using the CASE tool. Efficiency of using the CASE tools for designing the DB was highlighted thanks to this exercise.

After the definition of the target environment and some minor modification of mapping tables, students generated the PDM for MS SQL Server 2008 using the CASE tool functionality.

As a final results of DB process designing, students generated the code in DDL using the CASE tool as well and compared it with the PDM diagram. The code was used to generate the database during the second phase of training.

The training *Programming in T-SQL on MS SQL Server* 2008 was designed as a programming course in Transact-SQL language and covered selected groups of commands from DDL, DML (Data Manipulation Language) and QL (Query Language) – the SELECT command. The detailed description of training is presented in the table VIII.

C. Training Session Web Programming with PHP

This 15-hour training session was held during 5 days in sessions of 3 hours in the Faculty of Computer Science of the Voronezh State University for about 12 students. Its description is given in Table IX.

This training session was designed to serve as a first course in undergraduate web application programming in computer science curriculum. The prevailing atmosphere throughout the course was very nice and all students participated actively, asking questions and completing the exercises proposed. In addition, all students made the seminar project that was proposed.

Figure 7 shows a few students doing the exercises. In the background of this picture, the image of the teacher's presentation can be seen, since a video projector was used to display the teacher's presentation during the seminar. As it can be seen in this figure, each student had their own computer, because the seminar was mainly practical and students had to do many exercises and the seminar project.

Besides the slides, a public website was prepared to support the training seminar, see Figure 8. This website was updated in real time during the teacher's explanations to reflect the questions and doubts that students expressed during lectures, and thus encouraged students interactions. In this sense, the website was and is a true reflection of the training seminar that was given. The website was structured in four main parts:

- Course: the whole seminar, with lessons, exercises, and project explanations.
- Lessons: the lectures of the seminar.
- Exercises: the exercises proposed to do during the seminar.
- Project: the project explanations and documents needed to do the project.

During the training seminar, besides the proposed exercises, students had also to work on a personal project. The project was a web application inspired by Facebook: students had to develop miniFacebook, a very simple version of this wellknown social network and a topic particularly motivating for students. The aim of this project wasn't to create a perfect and complete social network, but a web application with the basic elements of a real social network.

The main features of the project were:

- To create a miniFacebook application with registered users through email and password.
- The application is divided into two connected but separated parts: the public area and the private area.
- In the public area, the list of users can be seen, but users' profiles or their posts can't be seen.
- To view the users' profiles and posts, a visitor must have an account and must be logged into the application.
- In the private area, a user can write and post messages, can modify his profile, and can delete his account.

Finally, in Figure 9, the web page to register as a new user of the application is shown. When registering into the application, the following information should be entered: full name, email, password, confirm password, date of birth, place of birth, information (e.g, description of the user), and nationality. This information is stored in a MySQL database that students had to create and manage. The web application phpMyAdmin was used as MySQL client.

D. Training Sessions Design Patterns in Java and Frameworks in Java

Both these two 10-hours training sessions were delivered over 5 days in Astrakhan, and then over 4 days again in Almaty. In Astrakhan the training had to take place 4 hours a day late in the evening because the attendees were busy during the rest of the time, whereas in Almaty more standard sessions were organized. The description of these sessions is presented in table X.

A full lecture on (Object-Oriented) Design Patterns may encompass software design, object-oriented basic concepts (encapsulation, state, behavior, inheritance, ...), design and programming techniques such as object delegation, classes and packages decoupling, building inheritance hierarchies, but also a full explanation of the concept of pattern, the way it can be described and the relations that one can put on them, pattern systems and languages.

Content reduction on this training session was handled this way: a brief history on patterns as an introduction, the presentation of the 23 famous design patterns of the "Gang of Four" (GoF) [9], and practical advices on how and when to use design patterns and a quick glance at the anti-pattern concept as a conclusion. In the main part of the lectures presenting the GoF, a very simple describing format was used pointing out the name of the pattern, the problem it is addressing and the principles of the proposed solution, its structure depicted in Unified Modeling Language and a brief discussion of the pros and cons of applying the pattern. Only 10 of the GoF patterns were presented with this low level of details (3 creational patterns, 3 structural and 4 behavioral ones), the 13 remaining patterns have only be cited for further reading while their principles were briefly compared to the 10 former patterns. After each pattern presentation, known uses of the pattern in Java predefined classes was also discussed to illustrate the importance of patterns in modern programming. Considering content reduction the lecture could have focused on a smaller number of design patterns but it was wanted to give the students an overview of the diversity and coverage of a whole patterns family.




Figure 10. Example of a lexicographic tree containing 7 words.

For encouraging student interactions and motivation, the lecture was highly backed by a single case study considered from the beginning of the session until the end of it: programming a lexicographic tree (see Figure 10). Instead of simply designing the classes, the students were asked to program so that a very practical approach such as the one of [10] is adopted.




Figure 11. Java classes involved in the lexicographic tree project.

The exercise started with the programming of 3 classes in a small inheritance hierarchy (AbstractNode, Node and Mark, see Figure 11), initially considering that only nodes are sufficient to implement a tree.

The difficulty to deal with an empty tree (*i.e.* a null reference in an AbstractNode variable) on the one hand, and the difficulty to encompass a tree as a whole on the other hand are then discussed with the students. This discussion leads to apply the Adapter pattern and create a new class LexicographicTree to improve the project. The Null-Object pattern (as described in [11] for example) is then presented and applied on the project to get rid of lots of null-reference checking in the programs, resulting in the definition of a new class EmptyNode in the node classes hierarchy. Finally the Singleton pattern is applied as an empty node being a factice node, there is no need to have several instances of EmptyNode. After applying each of these three patterns to the project, some time is taken with the students to discuss the improvements of the code and recall the role of each class in each applied patterns


The goal of the Frameworks training session was to show students how patterns are used in practice in common application development frameworks. The initial objective was to teach two different frameworks: MVC (Model View Controller) [12] illustrated on Java Swing and DAO (Data Access Object) illustrated on Java Persistence API. Since students were not familiar enough with Java technology and development, content reduction resulted on keeping only the MVC part.


The lecture was built along a single running example consisting of a model for a bounded integer. Students have been asked to refine and develop this example as concepts were introduced. After an overview of the MVC paradigm, the focus was step by step put on each part of MVC in order to build a view for the bounded integer model. At first, the model has been extended in order to be "Observable" (use of the Observer/Observable pattern), some extension of this pattern using delegation pattern has also been shown. After a brief presentation of Java Swing widgets, students were asked to build their own Graphical User Interface (GUI) for the given model. Finally the model was connected to the view by allowing the model to notify its changes to the view and by developing controllers in charge of updating the model following notifications of GUI widgets. At the end of the training, students obtained a fully functional bounded integer application built on their own (see Figure 12).

The last two hours of the Frameworks training have been dedicated to establish a link between the two training sessions. Students have been asked to build a MVC application for the lexicographic tree they developed in the Design Patterns training session (see Figure 13 for an example).





It was firstly planned to have the students attend the Design Patterns session before the Frameworks one as Frameworks can be thought as Patterns of higher level. However the two training sessions were mixed together afterwards as it was more comfortable for the students to vary their activities but it also helped the weakest students to gain more confidence in their Java skills prior to encountering the real difficulties of each training session. The heterogeneous level of students attending the sessions and the language issue was a problem for ensuring a smooth progression of the lecture and the exercises. The small number of students (10-15) attending the sessions however helped on these issues in some way as the most skilled students (either in English or in Java) spent some time to re-explain the weakest ones some points of the lecture in Russian. Using a single running example for each session was a good choice as students did not have to get familiar with several examples to progress in such a short period of time. This short period nevertheless did not benefit to the weakest students that did not end with fully working programs despite the efforts of the teachers to control the progression of the whole group.

IV. CONCLUSION

Training sessions for students in a Master "Informatics as a second competence" are interesting but also challenging for teachers, especially in the context of the ERAMIS project, because students and teachers come from different countries, and teaching is conducted in English, a second language for all. In this contribution we have exposed ways that have been used in the ERAMIS project to make teaching these sessions as effective as possible. Content reduction as well as encouraging and requiring both interactions and motivation are effective ways for a better teaching in any setting. In the context of the training session inside the ERAMIS project, they are even more valuable.

In general, participation of students during seminars was high. However, it was noticed a decline in participation when students and teachers attended the seminars together. In one of the seminars, one of the students was asked why they were not actively involved in the seminar. The answer was that, because of the respect they had for their teachers, they did not dare to ask questions in front of them. This fact can be taken as evidence that in the countries where seminars were conducted, there is still a large separation or gap between teachers and students. This comment should not be taken as a criticism to this situation, but as a finding of this situation, and as in some European countries this separation between teacher and student may have been lost, and eventually this lost has driven to a lost of respect.
